Dear Colleague:

Welcome to the second annual Military and Veterans Health Coordinating Board (MVHCB) Plenary Session. The primary purpose of our Plenary is to inform the members of our three Working Groups of issues that relate to the consequences of deployment upon the health of our service personnel and veterans. For the most part, the selected presentations will directly address progress made on Presidential Review Directive 5 (PRD-5) recommendations and on DoD Force Health Protection Program requirements. But, conference planners have also woven into the agenda several presentations on topics unique to the aftermath of the September 11th incident. The current 'war' we are fighting is not only taking place upon an uncustomary battlefield but also has seen the emergence of an unanticipated class of combatants in the form of postal workers, flight attendants, firemen and epidemiologists. Who would have thought that an ordinary letter would become the equivalent of an artillery shell or that a deployed environment would become an urban high-rise office building? Our Working Groups will be challenged to interpolate new concepts of the health consequences of 'deployment' with traditional ones as they formulate their 2002 action plans.

The secondary purpose of the Plenary is to allow others besides working group members who are interested in these topics to become more knowledgeable regarding this important work as well as to facilitate direct collaboration among members of the Services and the different agencies on these topics. Please note that the PRD-5 and the DoD Force Health Protection Program Capstone Document can be accessed on the MVHCB website (www.mvhcb.gov).

We have an ambitious program laid out for you over the next two and a half days that will provide you with a status update on a number of important topics pertaining to Research as well as to Force Health Protection and Deployment Health. The research will focus on both Gulf War illnesses as well as research for solutions to better protection of our military, veterans, and their families during and after future deployments. These initiatives will be focused in the following areas: Developing and Maintaining a Fit and Healthy Force Through a Continuum of Care; Functional Approaches to Collecting and Managing Data on Personnel and Exposures; Systemic Approaches to Evaluating and Managing Battle and Non-Battle-Related Risks; DoD/VA Life Cycle Health Surveillance System Capabilities; and the Development of Health Risk Communication Strategies and Skills.

If there is anything we can do to make this Plenary more enjoyable or beneficial for you, please let us know. I sincerely hope you enjoy our Plenary; we are glad you are here!
