Delays occur when we have to contact the station to request missing information on the PMO itself or missing attachments (i.e., biosketches for new site PIs, budget documents). Re-review of resubmitted PMOs adds a burden on our staff and causes delays in getting a response back to you. Please help us help you!

#### **Barnwell Applications due February 1**

Reminder: Nominations for the 2021 Barnwell Award are due by February 1, 2021.

The John B. Barnwell Award is CSRD's highest honor for outstanding achievement in clinical science research. Nomination packages are due by close of business on February 1, 2021.

The Barnwell Award is given for outstanding scientific achievements in clinical research that advance the diagnosis, prevention and/or treatment of diseases and disorders in the Veteran population.

Nominations may come from the VA Medical Center or CSRD can invite researchers to submit an application. **All applicants must apply through their local R&D Office.** To be eligible for the Barnwell Award, nominees must meet specific qualifications. 
